## **Yoga teachers, your rights... during this coronavirus period**

For Yoga teachers who are independent, in Society or Asbl... and active people who are retired...

1. You must fill out the "Formulaire de renseignements droit passerelle"  
(Forced interruption due to coronavirus)
2. Send it completed and signed to your social insurance fund (see address below)
3. You will receive an acknowledgment, but in the current context, the processing time can be long ...

Note: New measures for active retired people The royal decree prepared by the Minister of Self-Employed stipulates that active retired people whose income is greater than 6,996.89 euros (compulsory quarterly contribution of at least 257.14 €) can also benefit from the partial "droit passerelle" (807 euros / month if dependent, 645 euros if not dependent), with a maximum replacement income ceiling of 1,614 euros. In his press release, Mr. DUCARME declared: "The order of special powers will be adopted and published very soon. However, I asked the social insurance funds not to wait for the publication of this decree and to already pre-register the requests of the self-employed and active retired people who submit their request. So, when the special powers orders come into force, the funds will be able to pay this compensation as soon as possible. "
